WAIVER, ASSUMPTION OF RISK AND AGREEMENT TO HOLD HARMLESS

Please read carefully before signing. This is a release of liability waiver of certain legal rights.

I understand that the sport of dog agility, whether it be training, practice, or competition, is not without risk to myself, members of my family, guests who may attend club activities, or my dog. I acknowledge that dog agility has inherent risks, hazards and dangers that cannot be eliminated. I understand that injury may occur as a result of exposure to other dogs that could cause injury even when handled with the greatest amount of care. I also understand that injury may occur due to some failure of equipment used in the sport, even when such equipment is properly maintained. I understand that I have the physical conditioning and the degree of skill and coordination for me to engage in these activities safely. I understand that I have responsibilities to control my dog around other people and dogs. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks.

In consideration for my being permitted to participate in the activities of dog agility, I hereby release Muddy Paws Agility Club of Kitsap, its members, officers, and agents of the club, and the owners of the facilities that the club may use, and the owners of the agility equipment, from any and all liability of any nature, for injury or damage resulting from the action of any dog or failure of any training equipment. I expressly assume the risk of any such damage or injury while attending any club activity.

I, myself, my heirs, successors and executors, hereby knowingly and intentionally agree to indemnify and hold harmless Muddy Paws Agility Club of Kitsap, it's officers, members or agents, from any and all claims by any member of my family or any other person accompanying me to any club activity or while using the rented facilities, or the surrounding area thereto, as a result of any action by any dog, including my own, the failure of any training equipment and property fixtures or any other actions. All claims should include but not limited to, actions causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in all club activities including, but not limited to, negligence of any kind or nature, whether foreseen or unforeseen. I shall personally assume any and all responsibilities and liabilities for any loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of my dog or myself while participating in a Muddy Paws Agility Club of Kitsap function or event.
